## **Special Additional Conditions:**

The unit shall obtain No Objection Certificate (NOC) from the Tamil Nadu Bio Diversity Board/National Bio Diversity Authority if the unit is using any Biological resources or knowledge associated thereto as per the provisions of Biological Diversity Act 2002.

The industries shall take all efforts to use and popularize "Mission LiFE" logo and mascot which is available in TNPCB & MoEFCC website. They shall also request their employees to adopt "Mission LiFE" action points and document the same and furnish half yearly report to Board.

## **Additional Conditions:**

- 1. The unit shall commence the commercial production only after obtaining CPCB registration and on intimation to TNPCB.
- 2. The unit shall not manufacture banned plastic items as mentioned in G.O.84 dated 25.06.2018.
- 3. The unit shall treat and dispose the sewage through septic tank and soak pit arrangement.
- 4. The unit shall ensure that no trade effluent is generated at any stage of its manufacturing activities.
- 5. The unit shall comply with Plastic Waste Management Rules, 2016 as amended time to time.
- 6. The unit shall obtain certificate to manufacturer for marketing and selling of compostable products from CPCB, MoEF&CC, GOI New Delhi
- 7. The unit shall follow the standard operating procedure (SOP) for issuing certificate to Manufacturers/Sellers of compostable carry bags/products from CPCB, MoEF&CC, GOI New Delhi.
- 8. The unit shall apply and obtain EPR registration in CPCB portal immediately under Plastic Waste Management Rules, 2016 as amended.
- 9. The unit shall dispose the solid waste if any scientifically then and there without accumulation of the same for further beneficial purposes.
- 10. The unit shall maintain good housekeeping.
- 11. The unit shall not use "Use and throwaway plastics" such as plastic sheets used for food wrapping, spreading on dining table etc., plastic plates, plastic coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bag and plastic flags irrespective of thickness, within the industry premises which are banned by Government of Tamilnadu. Instead unit shall encourage use of eco-friendly alternative such as banana leaf, arecanut palm plate, stainless steel, glass, porcelain plates/cups, cloth bag, jute bag etc.,
- 12. The consent to operate is issued to the unit in consideration of the particulars furnished by the unit in its application submitted for CTO under the Water Act. If there is any variations (increase in the quantity of sewage generated or products manufactured (either in quality or quantity of the products) or if there is any generation of trade effluent the unit shall apply for fresh consent of the TNPC Board.
